# **EXECUTIVE SUMMARY**

**GUN**, \$GUN, is the native token of the GUNZ ecosystem, developed by **Gunzilla Games**. The token enables players to purchase, trade, and unlock in-game assets in the form of NFTs within titles built on the GUNZ platform. The GUNZ ecosystem serves as Layer-1 infrastructure for Web3 gaming, offering features such as in-game wallets, NFT minting, marketplaces, and developer tools.

Gunzilla Games, the company behind the token, is an independent AAA video game developer and publisher established in 2020. The studio operates across Frankfurt, Kyiv, and London. Its flagship title, Off the Grid, notably uses \$GUN as its in-game currency.

Gunzilla Games's ownership and management are centralized under founders **Alexander Zoll** and **Vladyslav Korolov**. They are supported by Christian Sullivan (Operating Partner and Board Member), Timur Davidenko (Chief Technology Officer), and Marina Danylyuk-Kemer (Chief Legal Officer).

Gunzilla Games, its founders, and key individuals have a **positive overall reputation**. Public discussions in media, gaming communities, and social platforms highlight the company's ambition to merge AAA game development with blockchain-based innovation.

According to our review, Gunzilla Games has not been involved in civil or criminal litigation. We can also confirm that the project has not been featured on anti-money laundering, debarment, prohibitive, or international sanctions lists.

Based on the above elements, Athena Intelligence has assessed Gunzilla Games as an overall low risk.



#### **PROFILE**

GUN serves as the native digital asset of the GUNZ ecosystem, developed by Gunzilla Games. The latter is a video game developer founded in 2020 by Vladyslav Korolov, Alexander Zoll, and Neill Blomkamp, with studios in Frankfurt, Germany; Kyiv, Ukraine; and London, the UK.<sup>1</sup> Although the company was established in 2020, its primary operating entity, now registered as Poseidon 133 Pte. Ltd., was incorporated in Singapore on 26 January 2015.

GUNZ is the native cryptocurrency of the GunZ Blockchain, a custom Avalanche Subnet developed by Gunzilla Games to add Web3 features to its main game, Off the Grid. The network supports in-game asset ownership, NFT trading, and basic governance. The \$GUN token is used for gas fees, marketplace payments, and player transactions within the ecosystem.<sup>2</sup>

The network operates on Avalanche's Proof-of-Stake consensus mechanism, offering scalable smart contract capabilities compatible with the Ethereum Virtual Machine. GunZ also incorporates Fireblocks technology for institutional-grade custody and transaction security. Developers gain access to SDKs through hacker.gunz.dev, enabling the integration of decentralized mechanics directly into gameplay.<sup>3</sup>

Regarding tokenomics, GUN's contract address is 0x26deBD39D5eD069770406FCa10A0E4f8d2c743eB, and its total supply is 329,917,144.4 \$GUN. The project's top five holders respectively own 33%, 13%, 10%, 9% and 5%, while the remaining 3,760 holders share the remaining 30%.<sup>4</sup>

Gunzilla Games announced in July 2025 that it would expand the \$GUN token to the Solana blockchain. The integration, facilitated by LayerZero bridging technology, leverages Solana's low-cost, high-speed infrastructure, enabling players to use Solana-based \$GUN within the Off the Grid ecosystem.<sup>5</sup>

Delphi Ventures, a crypto-focused venture capital firm specializing in early-stage decentralized technologies, has become the largest validator within the GunZ blockchain ecosystem.<sup>6</sup>

Since March 2025, Binance has listed \$GUN for trading, offering GUN/USDT, GUN/BNB, GUN/FDUSD, and GUN/TRY pairs.<sup>7</sup>

## **CORPORATE STRUCTURE**

As seen before, Gunzilla is headquartered in Frankfurt, with entities in Kyiv and London:

- German-based Gunzilla GmbH (2020) develops software and is managed by Alexander Karl. Poseidon 133 Pte. Ltd. (Singapore) is its sole shareholder. Alexander Zoll, Vladyslav Korolov, and Chan Wai Kwan manage Poseidon 133, which is owned by Mr. Zoll and Mr. Korolov (50% each).
- Gunzilla UK Ltd. (2021) publishes computer games and is jointly owned by Alexander Zoll and Vladyslav Korolov.
- Ukrainian-based Gunzilla (2020) conducts programming and related software trade activities. It is owned by Gunzilla LLC (USA), a Delaware-registered entity, with Mr. Zoll (60%) and Mr. Korolov (40%) as the reported ultimate beneficial owners.<sup>8</sup>

Gunzilla LLC was incorporated on 23 April 2020 in Kyiv, Ukraine. It focuses on (i) computer programming



and (ii) the trade of computers, peripheral equipment, and software. Oleksandr Voinarovskyi manages the company. Gunzilla LLC (USA) is its sole shareholder. Alexander Zoll (60%) and Vladyslav Korolov (40%) reportedly are its UBOs.

#### **MANAGEMENT PROFILE**

Although its team reportedly includes 262 members, its leadership notably comprises the five individuals listed below.<sup>9</sup>

#### Vladyslav Korolov – CEO

Mr. Korolov is a co-founder of Gunzilla Games and has served as its CEO since 2020. Before, he co-founded PLINK, a global matchmaking and social platform for gamers, and Gamecopter Capital, an initiative supporting innovation in the gaming industry (2018). He is also a Founding Board Member of SONUS, a communication platform designed for gamers (2018). Earlier in his career, Vladyslav Korolov co-founded and was the CTO of PAYMO, a payment-processing solution for online platforms (2013-2017). He also served as Deputy Commercial Director at CYBERPLAT.COM (2011-2014). Mr. Korolov holds a Bachelor's degree in Business Administration and Management from Santa Monica College in the USA.<sup>10</sup>

## **Alexander Zoll – Chief Strategy Officer**

Mr. Zoll is a co-founder of Gunzilla Games and has served as its CSO since 2020. He is also the founder of Gamegroove Capital, a firm supporting innovative projects and studios in gaming and technology (2018). Furthermore, Alexander Zoll co-founded the above-mentioned PLINK and SONUS. Before his entrepreneurial ventures, he spent over a decade at Crytek, where he served as CEO of the Kiev studio (2005-2018). Mr. Zoll holds a Master's degree from Coburg University and a Bachelor's degree from Staatl. Berufsschule I Coburg, in Germany.<sup>11</sup>

#### Christian Sullivan - Operating Partner and Board Member

Mr. Sullivan reportedly joined Gunzilla Games as an Operating Partner and a Board Member in 2024.<sup>12</sup> He reportedly is a seasoned investor with over 200 global investments, including Yubico – a manufacturer and vendor of authentication hardware devices; Moonpig – an online greeting cards and gifting platform; and Republic – an investment platform and fintech firm.<sup>13</sup> However, Christian Sullivan does not have a LinkedIn profile or other media presence, according to our review.

#### **Timur Davidenko – Chief Technology Officer**

Mr. Davidenko serves as the CTO of Gunzilla Games and SONUS, and as a Board Member of Gamegroove Capital, overseeing technological strategy and innovation (2020). Before, he spent nearly 19 years at Crytek, where he advanced to Technical Director for CryEngine (2001-2020). Timur Davidenko likely met with Alexander Zoll there. Earlier in his career, Mr. Davidenko worked as a Programmer at Enbaya – a manufacturer and service provider of prepaid utility meters (2001); 3Dion – a 3-D graphics studio and design vendor (1999-2001); and CompuGraphic (1995-1999). He holds a Master's degree from the Moscow Technical University of Communications and Informatics, Russia.<sup>14</sup>

# Marina Danylyuk-Kemer – Chief Legal Officer

Ms. Danylyuk-Kemer has served as CLO at Gunzilla Games since 2023. She has also co-founded and leads legal strategy at MiBit, a blockchain and fintech consulting firm (2021), is a Senior Legal Advisor at Swiss Blockchain Legal (since 2018), and is the Executive Director of Königsberger Bridges Institute (since 2017). Throughout her career, Marina Danylyuk-Kemer has held multiple senior legal roles, including serving as Head of Legal at Acquire.Fi (2022-2024), Chief Legal Officer at destream (2019-2025), MARK.SPACE (2018-2019), and TRAVOLIER.COM (2020-2022), as well as Chief Legal Advisor at SKCHAIN Advisors (2019-2021). Her earlier experience included serving as Assistant to the Director of Foreign Economic Activity at the

She holds a Master of Laws from Lomonosov Moscow State University, a Master's degree in Banking, Corporate, Finance, and Securities Law from Yaroslav Mudryi National Law University, both in Russia, and a Master's degree in International Economics from Donetsk State University of Economics and Trade, Ukraine.<sup>15</sup>

## **REPUTATION**

GUN is primarily referenced in online news media outlets and on X and is perceived as overall positive and neutral, respectively.

Regarding X, GUN has over 127,000 followers. Its posts are giveaways, OTG streams, and updates. 16
